COMPREHENSIVE PRIVACY NOTICE

ALUMINUM INDUSTRIAL AND SPECIAL PROFILES, S.A. DE C.V., PROSPECTIVE CUSTOMERS AND CUSTOMERS

In compliance with the Federal Law on the Protection of Personal Data Held by Private Parties (hereinafter "LFPD"), we make this comprehensive privacy notice (hereinafter "Privacy Notice") available to you, and in this regard, we inform you of the following:

1.- CONTROLLER OF YOUR PERSONAL DATA.

ALUMINIO INDUSTRIAL Y PERFILES ESPECIALES, S.A. DE C.V., (hereinafter AIPEsa), with address for hearing and receiving notifications at Avenida Prolongación López Mateos Sur, number 18000, interior 20, in Santa Cruz de las Flores, Tlajomulco de Zúñiga, Jalisco, is responsible for the processing and protection of the personal data we collect from you.

2.- INFORMATION ABOUT OUR PERSONAL DATA DEPARTMENT AND HOW TO CONTACT IT.

Our Personal Data Department is the one formally designated, in compliance with Article 29 of the LFPD, to: (i) address requests from data subjects to exercise their rights; (ii) promote and ensure the protection of the personal data in our possession. 3.- PERSONAL DATA WE COLLECT.

To carry out the purposes indicated in section 4 (four) of this Privacy Notice, we will collect personal data de las siguientes categorías: (i) Identificación; (ii) contacto; (iii) laborales; (iv) fiscales; (v) patrimoniales; (vi) financieros.

3.1.- SENSITIVE PERSONAL DATA AND DATA OF MINORS.

We inform you that we do not collect sensitive personal data or personal data from minors. If you are not eighteen years old, we ask that you refrain from providing us with your personal data.

4.- PURPOSES OF THE PROCESSING OF THE PERSONAL DATA COLLECTED.

Your personal information will be used for the following main purposes: (i) to identify you; (ii) to register you in our systems as a customer or prospective customer; (iii) to contact you by any means, including instant messaging services, online chat, and social media; (iv) to enable you to use mobile applications in connection with our products or services, including telematics and/or telemetry services; (v) to create a user ID to understand your preferences; (vi) to provide you with the information you request; (vii) to send you the price list for the goods, products, or services we offer; (viii) to invoice the products and/or services you purchase; (ix) to provide you with benefits; (x) to provide information required by government authorities or in compliance with applicable regulations; (xi) to address any (xii) compliance with our legal obligations and the exercise of our rights; and (xiii) providing you with payment options for our products and/or services through aggregators and/or acquirers. Additionally, your personal information will be used for the following secondary purposes: (i) to compile statistics and satisfaction surveys related to the purchasing or service processes, which may be conducted through instant messaging applications; (ii) to conduct video conferences, recordings, and/or videos to ensure your experience with our products and services; (iii) to inform you by any means about our products and/or services, as well as those of third-party companies; (iv) to invite you to events; (v) to carry out all types of marketing, advertising, promotional, or commercial prospecting activities; (vi) to conduct research, market analysis, customer profiling, and business situation

assessments; (vii) to create, study, and analyze your behavior on our websites and applications to personalize, optimize, and improve your experience with the brand, its products, and services.

4.1.- REFUSAL OF PROCESSING PERSONAL DATA FOR SECONDARY PURPOSES.

5. TRANSFER OF YOUR PERSONAL DATA.

We inform you that your personal data may be transferred, without your consent being legally required, to the following legal entities: (i) competent authorities, for the purpose of complying with any applicable law, regulation, or legal provision, or any duly substantiated and justified mandate; (iii) companies within our corporate group, which operate under our same internal processes and policies, for the purpose of providing you with better service; following up with potential clients; complying with our internal regulations and processes; as well as carrying out advertising, promotional, and marketing activities; (iv) Distributors and/or suppliers, for the fulfillment of the distribution contract; for the provision of AIPESA services.; compliance with the manufacturer's warranty; as well; (v) companies or associations with which we have a contract or are about to be signed that is in your interest, for the purpose of providing you with benefits. Your personal data may also be transferred, without your consent, if any of the conditions contemplated in Article 36 of the LFPD (Law on the Protection of Personal Data) arise.

6. YOUR RIGHTS.

Under the terms permitted by applicable regulations, you may access, rectify, or cancel (delete) your personal data, as well as object to its processing and
